#### **ORDINANCE 2015-1670**

# AN ORDINANCE CLOSING A PORTION OF A PUBLIC WAY, TO-WIT: A PORTION OF OLIVE STREET, MURRAY, KY.

WHEREAS, Murray State University has acquired certain real estate located around a portion of

Olive Street; and

WHEREAS, Murray State University proposes to erect a new physics/engineering building located near the public way seeking to be closed by this ordinance.

WHEREAS, the City of Murray published the intent by the City to close a portion of Olive Street (see Exhibit "A" (legal description) and Exhibit "D" (plat) both attached hereto and incorporated by reference as if fully stated herein, which represents the legal description of the portion of Olive Street to be closed). Comments were received by the Public Safety Committee and a referral was made to the Murray City Council for appeal.

WHEREAS, the Murray City Council held the appeal for the closures with no parties objecting to the closure. The appeal was then denied.

WHEREAS, the City of Murray and residents of Murray will still have reasonable access to the public highways and road of the community.

WHEREAS, in accordance with KRS 82.405, all adjoining land owners have been properly identified, notified and have given written consent (see Exhibits "B" and "C" respectively attached hereto and incorporated by reference as if fully stated herein), to the propose closure of a portion of Olive Street as referenced in Exhibit "A".

WHEREAS, the following findings are established:

- 1. All adjoining property owners in or abutting the public way or portions thereof to be closed have been identified:
- 2. All adjoining property owners in or abutting the public way or portions thereof to be closed have been notified, in writing, of the proposed closing (see Exhibit "B").
- 3. All adjoining property owners in or abutting the public way or portions thereof to be closed have given their written notarized consent to the closing (Exhibit "C").

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MURRAY, KENTUCKY, AS FOLLOWS:

Section 1. The City Council does, by the adoption of this Ordinance, declare closed that portion of a public way to-wit: A portion of Olive Street, which is more particularly described on the attached Exhibit "A" (legal description) and Exhibit "D" (plat) both made a part of this document by reference as if fully stated herein.

Nothing in this Ordinance hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing,

under any act or ordinance hereby repealed as cited in this Ordinance; nor shall any just or legal right or
remedy of any character be lost impaired or affected by this Ordinance.

## EXHIBIT "A"

#### PROPERTY DESCRIPTION

PORTION OF OLIVE STREET TO BE CLOSED

A 0.1147 acre (5,000.00 sq. ft.) tract of land as surveyed by Bacon Farmer Workman Engineering and Testing, Inc. in February 2015 and being a portion of Olive Street lying east of Broach Avenue, approximately 314.3' west of the centerline of North 16<sup>th</sup> Street and lying west of and adjacent to a previously closed portion of Olive Street as depicted on a Minor Subdivision Plat recorded in Plat Book 51, Page 41, Slide 4957, and being in the City Of Murray, Calloway County, Kentucky and being more particularly described as:

THENCE North 02 degrees 45 minutes 37 seconds East for a distance of 40.00 feet with a new line and the new east end of Olive Street to a point;

THENCE South 87 degrees 14 minutes 23 seconds East for a distance of 125.00 feet along the north side of Olive Street same being the south boundary of Commonwealth of Kentucky for use 4 benefit Murray State University property (D.B. 604, Pg. 568) to an Existing Iron Pin & Cap #4103 that bears North 87 degrees 14 minutes 23 seconds West 313.4' from the centerline of North 16<sup>th</sup> Street;

THENCE South 02 degrees 45 minutes 37 seconds West for a distance of 40.00 to the point of beginning.
